CALIFORNIA CAN'T AFFORD GOVERNOR GAVIN NEWSOM!

Newsom's term has 2 more years left; however, he is responsible for 3 more budget cycles! Newsom boasted, "As Governor, Newsom is working to 1) increase funding for public education, 2) protect and secure Californians' health and health care, 3) improve water, roads, and bridges, 4) address the challenges of housing affordability and homelessness, and 5) prepare for the threats of wildfires. Our budget is balanced. Our fiscal reserves are unprecedented. Our economy and employment are historically strong."

TOP REASONS TO RECALL CALIFORNIA GOVERNOR GAVIN NEWSOM ...

✘ HOMELESSNESS CHAOS & BORDER MISMANAGEMENT:

- CA=Highest National Homeless rate; 2024 Report: CA FAILED to track how BILLIONS of dollars were spent on homelessness programs
- Sanctuary State for Illegals & Criminals / Legal for illegals to sit on State boards & become police officers!
- Granted 700K illegals FREE health care, costing taxpayers \$3 billion annually
- Illegals get Tax Refunds, Welfare, Medical, Housing, Education, Food, Cell Phones ... **FREE!**

✘ PUBLIC SAFETY PURPOSELY IGNORED:

- Prop 47: Reduced Felonies to Misdemeanors for Violent Criminals; creating epidemic of smash & grabs/violent assaults
- Closed Prisons/Released thousands of dangerous criminals
- Granted Felons Clemency: Rapists, Murderers & Heinous Crimes Against Kids
- 2nd Amendment Infringement / No Longer Illegal NOT to Help an Officer in Need

✘ BUDGET CRISIS & ECONOMIC IMPACTS:

- **Budget deficit of \$73+ BILLION**
- Zero Accountability/Transparency on Spending/\$1.3 trillion debt in his first term
- 4% Salary Increase for Newsom (2019) but 10% Pay Cut to State Employees (2020)
- Assault on Businesses - Minimum Wage Increase; negative economic impacts
- Unneeded Bullet Train; cost in Billions
- Highest Poverty Rate & One of Highest State Sales & Property Taxes in Nation
- Prop 13 – Attempting to Restructure = Increased Property Tax
- PUC Appointments enacting income-based electric bills. Make more? Pay more!
- Income-based penalties for traffic violations – camera tickets
- Highest Gas Tax in Nation PRE-COVID19

- Redirecting Gas Tax; not used for improving infrastructure: roads, dams, bridges
- Millions waited/still waiting to receive unemployment
- \$1 BILLION in unemployment checks to prisoners w/\$2 BILLION in UIB Fraud overall
- Taxpayers fund transgender reassignment surgeries up to 700k people
- \$150 MILLION for Tattletale Hot Line
- Cut vital programs for veterans, school children, the disabled & the homeless

✘ **Extreme Government OVERREACH:**

- Massive Executive Orders – Acting w/o Legislature
- Overruling Vote of the People to Reinstate the Death Penalty
- Raise Gas Tax anytime w/o Voter Approval/ EO: Phase Out Gas-Powered Cars (2035)
- Orders PG&E Power Outages & Threatening to Take Over PG&E
- Approved Statewide Rent Control when it was voted down by the People
- 4 hydroelectric dams providing H2O & power to NorCal were removed
- Won't setup Water Claim Sys w/taxes collected for it; diverts funds for 'pet' projects
- Fighting to Stop Central Valley Farmers from getting needed water

✘ **Child Endangerment:**

- Divides Families: Misleads School Boards into enacting Parental Secrecy policies
- AB 665 – Allows minors to admit self into residential facility w/o parent permission
- Transgender sanctuary state
- School closures during Covid longer than other states; students fell behind in basics
- AB 1078 – Bans school boards from removing inappropriate school library books

✘ **Election Integrity Issues:**

- Unsolicited ballot mailed to all in CA/ Banned hand-counting ballots; exc. AB 969
- Outlawed individual counties from eliminating voting machines
- Uses his office to go after local officials not aligned with his Executive Overreach

✘ **COVID:**

- Excessive Shutdowns, Loss of Small Businesses & Jobs/Fraud in reporting COVID data
- \$1B on bad masks (China) v. American /\$12M spent on Arena w/9 patients treated
- Federal Covid funds for CA used on Homeless v. education, medical, safety & security

✘ **RULES FOR THEE, BUT NOT FOR HE:**

- French Laundry Indoor Dining: No Mask, 22 guests/ Failure to Pay His Property Taxes
 - Excluded HIS Panera Bread Donor from paying employees CA minimum wage increase!
 - His Winery employees NOT paid the new \$20/hr. wage minimum!
